

Dam Century Ride

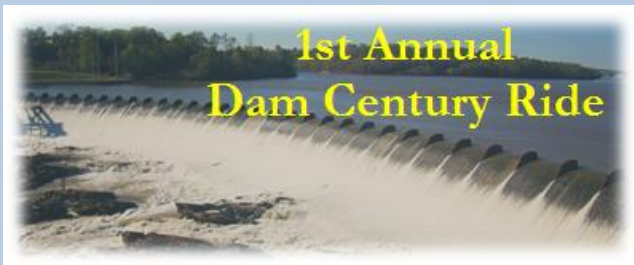
You can choose from three different challenging routes:

All routes will be a challenge, but you will find yourself surrounded by some of the most beautiful scenery in Alabama.

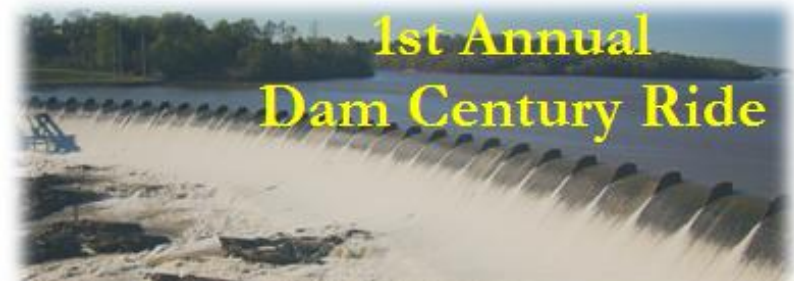
After the Ride, enjoy free food, music and fun as we celebrate the completion of the 1st Annual Dam Century Ride.

For the sole consideration of being permitted to participate in the **Dam Century Ride**, I, intending to be legally bound, hereby release and forever discharge the **Tallassee Chamber of Commerce**, and any sponsor, supporter, employee or

entity affiliated with **the Dam Century Ride**, along with any other volunteer, or owner/lessor of premises on which any part of, or any event associated with or related to the **Dam Century Ride** takes place, and all other firms, persons, and corporations liable, or who might be claimed to be liable (each considered to be one of the "Releasees" herein), from any and all claims, demands, damages, actions, causes of action, or suits of any kind and nature whatsoever, on account of any and all injuries both to my person and to my property, which may result from, or may in the future develop from, my participation in or travel to and from the **Dam Century Ride**. I understand that the Releasees are not responsible for, and are not insurers of, my personal safety during the **Dam Century Ride**. I also understand that bicycling is an inherently dangerous activity and that the **Dam Century Ride** is conducted on roads that will be open to the public and that other vehicles will be traveling on those roads during the **Dam Century Ride**. I fully realize and appreciate the dangers of participating in an organized bicycle ride. I realize that the **Dam Century Ride** requires physical conditioning and I represent that I am in proper physical condition to participate in this event. I fully assume any and all risks associated with my participation in the **Dam Century Ride**, including, by way of example only and not in limitation, risks of effects of weather, (including extreme temperatures or conditions), traffic, contact with motor vehicles of all types and descriptions, collision with other riders, pedestrians or fixed or moving objects, and the conditions of the road. I agree to follow all applicable traffic laws and to wear an ANSI- or SNELL- approved helmet at all times while riding my bicycle. I have completely read this release and I understand and accept the terms of it. I understand that the purpose of this release is to release all entities associated with the **Dam Century Ride/ Tallassee Chamber of Commerce** from any and all claims on account of any injury I might sustain during the event and that by signing this release I have given up substantial rights.
